**Information clause for members**  
**International Society for Molecular and Clinical Epigenetics in Szczecin (KRS 975115).**

In accordance with Article 13 of the Regulation of the European Parliament and of the Council of the EU on the protection of natural persons with regard to the processing of personal data of 27 April 2016. (Official Journal of the EU L 119 of 04.05.2016) we inform you that:

- (1) the administrator of your personal data is the International Society for Molecular and Clinical Epigenetics in Szczecin (KRS 975115), based in Szczecin (70-340) at 34/35 Bohaterów Warszawy Street, room 315.
